(The Clerk reported that Sergeant Lee Rees, was due to commence an Inspector's role on the 18 December 2018 and would no longer be working in Torfaen. Sergeant Rees had apologised if his replacement was not in place in time to attend the meeting.)

# CL18/070 Fire & Rescue Update

The Chairman welcomed Station Commander Andrew Good of South Wales Fire & Rescue Service.

Station Commander Good provided an overview of recent matters relating to the work of the Fire & Rescue Service. He described a period of relative stability and success and paid tribute to the proactive support received from Torfaen County Borough Council. He made particular reference to circumstances relating to road traffic incidents, explaining that most incidents took place at low speed or near existing hazards, such as in the vicinity of junctions. Gwent Safety Forum had identified an increase in road traffic accidents and work would be put in place to combat this. In answer to a question from a Member he explained that there were few "hot spots" in Cwmbran and that incidents of road traffic accidents were fairly generally spread across Cwmbran.

**Resolved** that Station Commander Good is thanked for his attendance and willingness to answer questions.

# CL18/071 Council Meeting 14 November 2018

# CL18/072 Events & Community Projects Committee 8 October 2018

Councillor PJ Cathcart Day introduced the minutes of the above meeting.

In relation to Minute ECP18/027 (Provisional Programme of Events), Members sought clarification on the circumstances relating to the decision not to hold a parade as part of the John Williams (Fielding) Act of Remembrance on 19 January 2019. The Clerk reported that, following concerns expressed by some Members, he had contacted the Chief Constable to express disappointment that there would be no parade taking place as part of the event. He also explained that he had suggested that representatives of Gwent Police might be able to explain the position at the meeting but they had been unable to attend (Minute CL19/069 above refers.)

The Clerk summarised advice received from the Chief Superintendent of Gwent Police which confirmed that, whilst officers would attend as long as operational commitments allowed, it was not possible for the police to be written into any traffic management plans for the event. The advice also referred to the potential for Torfaen County Borough Council to assist with providing advice in relation to marshals. The Clerk undertook to circulate the full Police advice to Members.

Members expressed their disappointment at the circumstances surrounding the decision not to hold a parade for the above event. Members were disappointed at the position taken by the police and instructed the Clerk to make representations to the MP, Police Commissioner and local members of the House of Lords about the circumstances. Members also instructed the Clerk to contact Torfaen County Borough Council to clarify when Torfaen County Borough Council were made aware of the circumstances.

# Resolved that

- (2) the Clerk is instructed to take forward the Council's concerns relating to the John Williams (Fielding) Act of Remembrance on 19 January 2019 as described above.

In relation to Minute PF18/061 (5) ("Council House" Matters: Update), the Clerk reported that, in relation to the acquisition of a secure Infra-Red Hearing Aid Induction Loop system, a quotation had been obtained based upon ex demo equipment but with a 12 month warranty. A quotation had also been requested based upon new equipment. Members considered that new equipment would be preferable to "ex demo."

In relation to Minute PF18/061 (6) ("Council House" Matters: Update) the Clerk also reported details of the officers nominated as points of contact in relation to the Intruder Alarm. One of the contact officers would be contacted following a single activation of the alarm and the police were also contacted in the event of a confirmed activation (for example, a second activation) of the system. There was no direct link to the Fire & Rescue service from the fire alarms.
